<u>JOINT FACILITIES OPERATIONS AND FINANCES</u>

Mr. Burke first reported on the status of leak repairs at water plant no. 2 and the status of recoating the interiors of the hydro-pneumatic and ground storage tank interiors at water plant no. 1. He said there are minor leaks in tank no. 2 at water plant no. 2 and that SEC plans to take tank no. 2 out of service in the winter to vacuum test to locate the leaks.

Mr. Burke next discussed the District's pending permit renewal for the wastewater treatment plant and installation of two Ebara pumps at lift station no. 3 on Jarvis Road.

TRAIL IMPROVEMENT/CONTINUATION REPORTS

Mr. Beard reported on the status of connections to the trails at The Park at Arbordale and Director Silverman reported on the installation of birdhouses on District trails.

The Board and No. 364 also discussed signage and trash cans on District and No. 364 trails and maintenance of same.

SECURITY REPORT

Director Bradley reported regarding a recent break in at the wastewater treatment plant. The Board and No. 364 discussed security, generally, and area crime issues.
